

## **Uchenna Academy Scholarship Contract**

for Students attending Uchenna Academy

This Scholarship Contract ("Scholarship") is entered into between (Student's Name), hereinafter referred to as the "Student" and Uchenna Academy Inc., hereinafter referred to as the "School." The Contract is awarded to deserving Students who demonstrate exceptional academic achievement, athletic abilities, or both, as per the eligibility criteria outlined in the School's scholarship guidelines.

1. **Duration:** This Scholarship is effective for the academic year (Start Date) to (End Date).

# 2. Conditions for Cancellation or Modification for either the Athletic or Academic Scholarship:

The Athletic Scholarship may be canceled or modified under the following circumstances:

- If the Student becomes ineligible for participation in athletics due to academic or disciplinary reasons.
- For misconduct (unrelated to athletic ability) investigated and confirmed by the administration team at our school.
- If the Student fails to adhere to the school's Code of Conduct or engages in any behavior inconsistent with the principles of good citizenship
- If the Student voluntarily withdraws from basketball competition (regardless of the reason).
- If a Student is injured during the season, the athletic scholarship will not be renewed

The Academic Scholarship may be canceled or modified under the following circumstances:

- If the Student becomes ineligible for academic participation due to failing to maintain the required term average of 90% or any other academic criteria specified in the scholarship offer.
- For misconduct unrelated to academic performance, as investigated and confirmed by the administration team at our school.



- If the Student voluntarily withdraws from academic activities (regardless of the reason).
- If the Student fails to adhere to the school's Code of Conduct or engages in any behavior inconsistent with the principles of good citizenship

#### 3. Review and Eligibility:

The scholarship will be reviewed bi-annually in July and January by the School's Board of Directors. If the Student fails to meet the eligibility criteria communicated in the scholarship offer, either academically or athletically, the scholarship may be revoked.

#### 4. Notification:

The School will provide written notice to the Student in the event of cancellation or modification of the Scholarship, specifying the reason for such action.

#### 5. Appeals Process:

The Student may appeal the cancellation or modification of the Scholarship within 14 days of receiving notice. The appeal must be submitted in writing to the School's Board of Directors.

#### 6. Compliance:

The Student agrees to comply with all rules and regulations of the School, both academically and athletically.

#### 7. Scholarship Renewal:

The Scholarship may be renewed for subsequent academic years based on the Student's continued eligibility and performance.

#### 8. Governing Law:

This Contract shall be governed by the laws of Ontario, and any disputes arising out of or relating to this Contract shall be resolved in accordance with the School's dispute resolution procedures.
